The purpose of this letter is to emphatically support the Transportation Investment Generating Economic Recovery (TIGER 2017) Grant Application for multi-modal connections to Kansas City's Berkley Riverfront. The Kansas City Power & Light District, located at 50 East 13th Street in Kansas City, Missouri, represents a constituency of 45 retailers and businesses, residential properties, and thousands of employees, downtowners and residents spread within our nine city blocks.

The Riverfront will draw new residents, businesses, and visitors to downtown and strengthen our urban core.
