The Labor-Management Council of Greater Kansas City strongly supports the Better Utilizing Investments to Leverage Development (BUILD) Grant Application for multi-modal connections to Kansas City's Berkley Riverfront. Our mission is to enhance collaboration among the more than 80 companies, unions and governments in the Kansas City region that we represent, and have been for 39 years.

We applaud the local government teamwork involved with KC•CORE, including the Kansas City Streetcar Authority, Port Authority of Kansas City, MO, the City of Kansas City, Mo. and the grant Applicant – the Kansas City Area Transportation Authority. This coalition is providing direct financial support to deliver what would be a popular, three-quarter-mile extension of the highly successful KC Streetcar by 2021.
