The purpose of this letter is to emphatically support the Transportation Investment Generating Economic Recovery (TIGER 2017) Grant Application for multi-modal connections to Kansas City's Berkley Riverfront. Flaherty and Collins Properties is the Developer of a \$75,000,000.00 410 unit multi-family project now under construction on Berkley Riverfront at 500 Berkley Parkway, Kansas City, MO 64105. The Streetcar will add value to our project by allowing greater access to all of cultural, recreational, business, and employment in downtown for our tenants and increase the viability of our retail and office space.
