Thank you for submitting information on the above referenced project for our review pursuant to Section 106 of the National Historic Preservation Act (P.O. 89-665, as amended and the Advisory Council on Historic Preservation's regulation 36 CFR Part 800, which require identification and evaluation of cultural resources.

We have reviewed the Section 106 Technical Report entitled *Kansas City Main Street Extension Project* by Architectural & Historical Research, LLC. Based on this review it is evident that a thorough and adequate architectural resources survey has been conducted of the project area. We concur with your recommendation that 1 East Pershing Road, 3021, 3035-37, 3041-45, 3240, 3244, 3415-29, 3517, 3620, 4041, 4307, 4536-58, 4545, 4553-55, and 4601 Main Street are eligible for inclusion in the National Register of Historic Places (NRHP). In addition, we were unable to determine if the properties at 2525, 2837, 2841, 2835, 2940, 3601, and 4200 Main Street, 1 West Armour Boulevard, and 47<sup>th</sup> to 51<sup>st</sup> Streets are eligible for listing in the NRHP. However, we concur that the instillation of streetcar tracks along Main Street will have **no** adverse effect to historic properties, and we look forward to consulting on the design and construction of new platforms for streetcar stops that are within or adjacent to historic properties to ensure they are in keeping with the *Secretary of the Interior's Standards for Rehabilitation*, namely Standard 10.

Please be advised that, should project plans change, information documenting the revisions should be submitted to this office for further review. In the event that cultural materials are encountered during project activities, all construction should be halted, and this office notified as soon as possible in order to determine the appropriate course of action.
